

Practical experience requirement (PER)	Both pathways require you to log at least three years of verified, relevant, work-based experience while completing the Professional Qualification. This ensures your mastery of real-world finance, accounting and business skills.		
Award	After successfully completing either pathway, you will become a CIMA member and be awarded the use of CIMA designatory letters (ACMA or FCMA), as well as the CGMA designation.		
Fees	You will pay a one-time registration fee, pay for your chosen learning methods and pay for each exam you sit.	You will purchase a one-, two- or three-year subscription that includes registration, learning, exam preparation courses, all assessments and Case Study exams.
